

# Safeguarding Annual Report 2023

When I joined the DSSG in April 2023, I was not sure of the structure I would find and what was the quality of the staff in the safeguarding team. I found dedicated, experienced professionals who had a valuable mix of safeguarding related backgrounds. The team was well led and supported with governance which is well set and, thankfully, complacency did not seem to be a problem.

This seemed complimented by the Bishop and her senior leadership team who are committed to best practice and highly



supportive of the staff. During 2023 the communications team were reforming and now they are supportive and , in my opinion, an essential arm of the work.

Representation and collaboration with the Cathedral and the College is strong.

Being part of the Pathfinder regional initiative has brought an extra dimension to the work and, I believe, has the opportunity to be a valuable support network in the South West. Having colleague Chairs to discuss issues does help decision making.

I would commend the work that the team and senior leadership support.

Towards the latter part of 2023 details emerged of a forthcoming comprehensive audit of safeguarding in all Dioceses. Our one was scheduled for March 2024 and work was started by Adam and the team during Advent 2023.

Although there are possibly some significant changes to the Church's safeguarding structures, I have confidence that Bristol is well served.

'Quarterly Metrics' are provided at each meeting as well as updates regarding use of the Parish Safeguarding Dashboard by parishes. This has been particularly effective. These figures report on training, casework and DBS compliance levels.

# **Safeguarding Service Development**

#### **Diocese**

<u>Inductions:</u> One-to-one Safeguarding Inductions for Clergy and DBF Advisers/ Officers were continued during 2023.

<u>Trinity College</u>: Trinity College in Bristol is the only Theological Education Institution (TEI) within the Diocese of Bristol. Support is provided to Trinity College with safeguarding issues including the provision of advice and guidance on safeguarding arrangements within the College and the provision of safeguarding training to both staff and the student body.

Out of Hours/ Holiday Advice Access: An Information Sharing Agreement is in place with Thirtyone:eight<sup>1</sup> to enable individuals from Parishes to access their 24 hour helpline and for urgent telephone advice to be provided during DSO leave. Requests for advice are shared with the Diocese though we do not at present receive usage data.

#### Regional

<u>South West Safeguarding Trainers Network:</u> A network for safeguarding trainers in Church of England Dioceses in the South West. The group has established itself and meets quarterly to provide support and share good practice across the region.

<u>South West Independent Chairs (SWItCH):</u> meeting quarterly to share good practice and provide support amongst independent chairs.

Regional DSO meeting: these are now established as quarterly meetings and are facilitated by the Regional Safeguarding Lead as part of the National Pathfinder project in response to the IICSA recommendations 1 and 8.

#### **National**

<u>Pathfinder Pilot project:</u> The Diocese of Bristol is part of the pathfinder pilot project to address recommendations 1 and 8 of the IICSA report in order to contribute to the improvement of safeguarding arrangements in the church as a whole. The Pilot project has embedded regular supervision and support for the DSO and TEam from the regional safeguarding lead. Opportunities for collaboration and mutual support are also being explored led by the regional lead. A Quality assurance framework will be implemented during 2024.

<u>Independent Safeguarding Audit Programme:</u> The Diocese volunteered to be an early participant alongside Bristol Cathedral in the independent safeguarding audits of dioceses and Cathedrals. The Audits will be conducted by INEQE<sup>2</sup> and the initial phase of information gathering, and submission commenced in November 2023. The final report for Bristol will be published during the summer of 2024

# **Policy and Procedures**

#### **Diocese**

No new policies or procedures have been issued at a Diocesan level. During 2023 all Diocesan policies, procedures, guidance and supporting documentation was reviewed and updated. The Safeguarding pages of the Diocesan Website were updated and restructured with revised information.

#### **National**

Safeguarding Practice reviews guidance was issued during 2023 alongside revised guidance for Local Ecumenical Partnerships. We are expecting revisions to the managing allegations guidance safeguarding learning and development guidance during 2024.

The new National Safeguarding Standards<sup>3</sup> were issued in October 2023. These will be implemented and embedded across the church over the coming 2-3 years.

# Safeguarding Training

During 2023 the Diocesan team have continued to provide the full range of core and specialist training as required in the Church of England Training and Development Framework (2021) The framework is currently being updated, the new version will be published this summer.

In addition to the mandatory training, we have also provided or contributed to the following training:

- Personal Safety and Lone working
- Mental Health First Aid
- Mental Health Awareness
- Deliverance Ministry
- Safeguarding induction for new curates
- Safeguarding for discernment candidates

Attendance numbers are strong and participants continue to be well engaged. The feedback we get is overwhelmingly positive. The pre work and course materials are very academic which sometimes provokes some negative responses. We have adapted the material and provided feedback to the national safeguarding team. We had one participant in 2023 who gave very negative feedback and we followed up with them to discuss their comments and concerns.

Here are some examples of the feedback received in 2023:

#### **Safeguarding Training Courses**

The full suite of training available within the Diocese is as follows:


- **Basic Awareness** pre-requisite for all face to face training and recommended for all, available online via the safeguarding training portal.
- Foundations course provides an introduction to safeguarding within a
  church context and equips participants with skills and knowledge to know
  how and when to report concerns (available online via the safeguarding
  training portal).
- Leadership Equips participants to embed safeguarding practice in a leadership role within their church. It is a two part course which includes pre course requirements and post course evaluation.
- **PTO Pathway** This is a bespoke leadership training for any clergy or Licensed Lay Minister holding PTO in the diocese.
- Parish Safeguarding Officer Induction Pathway. This course aims to
  engage and equip all Parish Safeguarding Officers with information they
  need to complete the varied aspects of this important role. The course
  includes information on what to do in the case of a safeguarding disclosure,
  managing risk, safer recruitment and use of the parish dashboards.
- Safer Recruitment and People Management Explores statutory legislation and guidance and the House of Bishops safer recruitment procedures, policies and practice guidance (available online via the safeguarding training portal).
- Raising Awareness of Domestic Abuse Exploring the nature and dynamics of domestic abuse, with a focus on church settings (available online via the safeguarding training portal).
- Personal Safety an additional course provided to support clergy and other church officers whose role will often require them to work alone. Developed from training provided by the Suzy Lamplugh Trust<sup>4</sup>

#### Online training

The online training provision comprises Basic Awareness and Foundations, Domestic Abuse and Safer Recruitment. There is also a module available regarding Modern Slavery and Human Trafficking.

# Monitoring and reporting

Monitoring of levels of training for those holding a Bishop's licence or permission to officiate, DBF staff and Parish Safeguarding Officers is reported at each DSSG meeting. Failure to complete Safeguarding training can result in suspension of a licence.

#### **DBS** and **Safer Recruitment**

Any role in a Parish that is eligible for a Disclosure and Barring Service Check should have one completed prior to a person being appointed to that role. Every parish has access to the DBS system provided by Thirtyone:eight, either directly or in a one case through the Diocesan Safeguarding Team. The Safeguarding Team also works with the DBS Regional Outreach Adviser to provide workshops for Parish Lead Recruiters covering DBS eligibility and use of the DBS Update Service.


All Church officers that are required to have a current DBS check should ensure it is renewed every 3 years.



#### Case Work


All cases are recorded on the National Safeguarding Case Management System (NSCMS). Either where advice is sought from the DSO and is related to a safeguarding concern or has the potential to require a degree of intervention by the Diocesan Safeguarding Team or other types of queries e.g. recruitment, DBS, policy, training, signposting to services for parishioners.

#### Number & category of new cases opened per quarter

An updated Case Management System, implemented during 2022, has meant that the way cases are recorded has changed. During 2023 every concern, whether a safeguarding case type of query, was recorded in the same system and reported together using the categorisation provided by the National Safeguarding Team. In Bristol, the categorisation system was implemented from April 2023 and consistent recording became available after that date and is broken down below.

## Safety Plans (formally known as Safeguarding Agreements)

During 2023 the terminology for these types of arrangements changed and they are now known as Safety Plans. A safety plan is put in place when an individual who poses a risk to children or adults at risk would like to attend and worship at a church. Prior to the implementation of a plan, a risk assessment is completed to ensure that the plan fully meets the risk posed and that the individual is provided with the necessary support.

As at December 2023, there were 16 active plans in place involving 15 individuals.
